Town Board Proceedings of September 9, 2025

The Regular Board Meeting of the Bear Creek Town Board was held at the Bear Creek Town Hall, on September 9, 2025. Chairman Travis Nachreiner called the meeting to order at 7:00 p.m.

The following members were present: Travis Nachreiner, Chairman; Jeff Scallon; and, Tyler Wiedenfeld, Supervisors.

Others present: Donna Lins, Treasurer; Tim McCluskey, Patrolman; and, Sheila Carver, Clerk.

Wiedenfeld motioned to adopt the agenda as presented. Scallon seconded. Motion carried.

Scallon motioned to approve the August 12, 2025 Regular Board meeting minutes. Wiedenfeld seconded. Motion carried.

The Treasurer gave the Treasurer's Report. Wiedenfeld motioned to approve the Treasurer's Report with a correction. Scallon seconded. Motion carried.

Scallon reported no building permits.

Wiedenfeld motioned to adopt Resolution #2025-03: Mutual Aid Box Alarm System Agreement. Scallon seconded. Motion carried.

With no public comment, Scallon motioned to adopt Resolution #2025-04; a resolution adopting the Sauk County Hazard Mitigation Plan: 2025-2029. Wiedenfeld seconded. Motion carried.

Scallon motioned to adopt Ordinance SEPT2025: An update to the Responsible Unit Recycling Ordinance. Wiedenfeld seconded. Motion carried.

Wiedenfeld motioned to approve a temporary liquor license for St. Patrick's for their fall festival on September 21, 2025. Scallon seconded. Motion carried.

Dane Hill Road will be paved soon. There was a complaint about kids with four-wheelers on Dawn Road after the seal coating; they have been notified. There were issues with mowing on Garvey Road. The winter salt order needs to be placed, estimating 22-23 tons of salt. We will require 10-11 loads of sand to fill the shed. Nachreiner is working on adding the extension of Lehner Road to the state mapping. Strang Hollow will be patched soon. There are issues with the truck. The mower needed bearings. The Chapel Lane turnaround is complete.

The Fire District held a meeting last night. A new EMS chief, Trevor Strine, was hired. EMS has responded to 138 calls so far this year, compared to 121 at this point last year. The fire department has handled 50 calls this year. The mill rate decreased from .75 to .67 to fund a new fire truck and ambulance by 2029.

October's meeting is scheduled for Thursday, October 9, 2025.

The Board approved expenditures totaling \$104,168.54.
