Scallon reported no building permits. Sauk County plans to build a maintenance building at White Mound. Paul Wittmann is adding on to his barn.

Frosch is doing clearing work on Ridge Road. Nachreiner submitted the grant application for the Cummings Road project. Planning to solicit bids in early 2026. Sand and salt for the winter have been received.

A letter to Town & Country will be drafted, expressing dissatisfaction with the recent service.

The Board approved expenditures totaling \$32,892.46.
