Town Board Proceedings of February 8, 2022

The Regular Board Meeting of the Bear Creek Town Board was held at the Bear Creek Town Hall, on February 8, 2022. The meeting was called to order by Chairman Marty McCluskey at 7:00 p.m.

The following members were present: Marty McCluskey, Chairman; Jeff Scallon; and, Steve Emerson, Supervisors.

Others present: Donna Lins, Treasurer; Tim McCluskey, Patrolman; Ted Greenheck, Plan Commission Chair; Robbin D'elene; John W Borntreger; Richard Kruse; and, Sheila Carver, Clerk.

The minutes of the January 11, 2022 Regular Board Meeting were read by the Clerk. Scallon motioned to approve the minutes. Emerson seconded. Motion carried.

The Treasurer's Report was given by the Treasurer. Scallon motioned to approve the Treasurer's Report. Emerson seconded. Motion carried.

Scallon had no building permits to report.

Plan Commission Chair, Ted Greenheck, presented a Conditional Use Permit (CUP) #05-2022 request for John Borntreger, S7991A County Rd G, for a wood fabrication business with the intention of manufacturing pallets. The Plan Commission recommends approval of this petition with the following conditions: Sauk County Planning and Zoning (SCCPZ) Conditions A-N; Property signage, such as "Slow, Children at Play"; Sauk County shall install signage on County Road G, including at a minimum, "School Zone" signs and "Truck Entrance" signs within 30 days of issuance of this CUP; Adult supervision required at recess time, before school and after school in order to watch for trucks; Hours of operation shall be restricted to 7:00 a.m. to 6:00 p.m. Monday through Friday, and Saturday 7:00 a.m. to noon; The CUP shall be non-transferrable; Maximum of 10 workers; and, Increase culvert width to 60' for semi turning radius. Scallon motioned to approve the CUP #05-2022 with the Plan Commission recommendations. Emerson seconded. Motion carried.

Scallon motioned to set the audit meeting for Tuesday, March 8, 2022 at 6:30 p.m. Emerson seconded. Motion carried.

Scallon motioned to reschedule the annual meeting for Wednesday, April 20, 2022 at 7:00 p.m. Emerson seconded. Motion carried. The Clerk needs to publish this meeting.

Sauk County Highway Commissioner, Pat Gavinski, contacted Marty in regards to Croal Road needing two narrow bridge warning signs. Sauk County will install the signs and invoice the Township. A similar sign should be replaced on Deitl Road. Marty will discuss Deitl Road with Gavinski. If needed, Sauk County can take care of this sign as well.

The mower head that was budgeted for will be received in July, according to Diamond Mowers.

The ATV/UTV Club is coming to the March meeting to ask to add Marble Quarry Road to routes.

The board approved expenditures totaling \$362,765.05.

Scallon motioned to adjourn at 7:51 p.m. Emerson seconded. Motion carried.
