Town of Bear Creek Town Board Proceedings of October 9, 2025

The Regular Board Meeting of the Bear Creek Town Board was held at the Bear Creek Town Hall, on October 9, 2025. Chairman Travis Nachreiner called the meeting to order at 7:00 p.m.

The following members were present: Travis Nachreiner, Chairman; Jeff Scallon; and, Tyler Wiedenfeld, Supervisors.

Others present: Kevin Meise; Donna Lins, Treasurer; Tim McCluskey, Patrolman; Ted Greenheck: Plan Commission Chair; and, Sheila Carver, Clerk.

Wiedenfeld motioned to adopt the agenda as presented. Scallon seconded. Motion carried.

Scallon motioned to approve the September 9, 2025 Regular Board meeting minutes. Wiedenfeld seconded. Motion carried.

The Treasurer gave the Treasurer's Report. Scallon motioned to transfer \$30,000 from the Reserve Account to the General Fund. Wiedenfeld seconded. Motion carried. Wiedenfeld motioned to approve the Treasurer's Report with a correction. Scallon seconded. Motion carried.

Scallon reported building permits for a shed for Mitch Gilbertson and a house permit for Ervin Bontrager.

Ted Greenheck presented a Certified Survey Map for Leo Perna/Kevin Meise for one lot (15.66 Acres) on Kessinich Road. The Commission recommended approval. Scallon motioned to recommend approving the Certified Survey Map as presented. Wiedenfeld seconded. Motion carried.

Wiedenfeld motioned to set the budget preparation meeting for Wednesday, October 29th at 6:30 p.m. Scallon seconded. Motion carried.

There will be no more patching on Cummings Road this year. A tire is needed for the truck. An intent to cut at the O'Neil property on Highway G was received. One garage door needs maintenance.

Nick Heiser Trucking charges \$11.50 per yard for sand. With 16 yards per load, that amounts to \$184 per load. They will truck salt for \$130 per hour. The cost for the salt is \$2,675 for 23 tons.

Nachreiner received an informational estimate for 2026 to pulverize and double chip seal Cummings Road at a cost of \$108,330. The base exists, but the surface is gone. Nachreiner will compile some numbers. The clearing and grubbing are significant on that road.

The November meeting is scheduled for Monday, November 10th, which will start with the budget meetings.

The Board approved expenditures totaling \$127,694.29.

Scallon motioned to adjourn at 7:49 p.m. Wiedenfeld seconded. Motion carried.
